A. Kiwanis Family Park Update- Splash pad is on schedule. All the bridges have been power washed and look great, all the bad spots on the Greenway through Kiwanis Park have been repaired.

B. Master Plan Progress Update- all the schematic designs are in, the county is in the process of reviewing the designs. If there are any comments we will get them back to Withers/Ravenel so they can proceed on the actual designs and working up cost estimates.

C. Lett Family Park Update- Playground should be arriving soon, tried to call the Rep today had to leave a message. At one time, they said the playground would be there the last week of June; here we are and still haven't seen it. Chad Spivey asked if the playground was the last thing that needed to be done at that park. John Payne said that General Services is trying to get quotes for the roof.

D. Bird Pens at San-Lee Park- They were delivered on Friday and still need some adjusting. They installed 6 anchors and will come back tomorrow to add 4 more because the plans call for 10 anchors total. John said it looks great! It will still be 2-3 weeks before we move the birds in; we want to finish any work need so we don't put any unneeded stress on the birds.
