MINUTES OF THE LEE COUNTY FIRE ADVISORY BOARD

May 14, 2014

The Lee County Fire Advisory Board (FAB) met on May 14th at Lee County Emergency Services, located at 204 West Courtland Drive, Sanford, North Carolina.

Chairman Donald Andrews called the meeting to order at 6:00 p.m.

Minutes from the April 16, 2014 meeting were accepted as presented. Motion made by Kirk Smith, seconded by Larry Kelly; unanimous vote.

The agenda was approved by a motion made by Kirk Smith, seconded by Richard Holshouser; unanimous vote.

The Fire Advisory Board met individually with each of the fire department representative(s) listed below for a one-on-one question and answer budget session:

During the meeting, several fire departments requested that they would like to receive a projected tax base for the upcoming year, as well as, what one cent in tax rate generates in revenue. They expressed that it would be extremely helpful if they could have this information available when they receive their budget packets in January to allow for better budget planning.

After meeting with the fire department representative(s), the FAB discussed the FY 2014/15 budget requests at length. Larry Kelly made a motion, seconded by Kirk Smith, and carried by unanimous vote to recommend to the Lee County Board of Commissioners the approval of the FY 2014/15 Fire Department Budgets as requested, and/or modified, with the following projected fire tax rates:

Northview	\$0.087
Cape Fear	\$0.10
Deep River	\$0.118
Tramway	\$0.089
