MINUTES OF THE LEE COUNTY FIRE ADVISORY BOARD

May 9, 2016

The Lee County Fire Advisory Board (FAB) met on May 9th, 2016 at Lee County Emergency Services, located at 204 West Courtland Drive, Sanford, North Carolina.

Chairman Donald Andrews called the meeting to order at 6:00 pm.

Minutes from the April 21, 2016 meeting were accepted as presented. Motion made by David Vann, seconded by Kirk Smith; unanimous vote.

The agenda was approved by a motion made by Richard Holshouser, seconded by Kirk Smith; unanimous vote.

No one was present to make any public comments.

A joint Q & A session between the FAB and representatives of the county's volunteer fire departments was conducted to obtain answers to questions regarding their FY2016-17 budget requests or to express concerns.

Budget information received was discussed at length amongst the FAB; recommendations for approval of each respective budget request was made based on the following motions:

Kirk Smith made a motion to approve the budget request for Cape Fear FD, as presented; seconded by David Vann; vote carried unanimously.

Kirk Smith made a motion to approve the budget request for Carolina Trace FD, as presented; seconded by Charles Baker; vote carried unanimously.

Kirk Smith made a motion to approve the budget request for Deep River FD, as adjusted; seconded by Richard Holshouser; vote carried unanimously.

David Vann made a motion to approve the budget request for Lemon Springs FD, as presented; seconded by Kirk Smith; vote carried unanimously.

Richard Holshouser made a motion to approve the budget request for Northview FD, with the changes requested by the department; seconded by Kirk Smith; vote carried unanimously.

Cy Richardson made a motion to approve the budget request for Northwest Pocket FD, and the resulting increase in the fire tax rate; seconded by Richard Holshouser; vote carried unanimously.


Kirk Smith made a motion to approve the budget request for Tramway FD, as presented; seconded by Cy Richardson.
